- We welcomed Acting Deputy Superintendent Jon Rever as our November guest speaker, to discuss Family and Community Engagement. I have attached Jon's slides for your reference and to share with your PAC. I look forward to hearing how your schools work to involve more parent engagement and school community learning plans/goals in your PAC meetings!
- Provincial Landscape: We have requested that PACs go ahead and pay their BCCPAC fees if they are able/willing. We have the capacity to cover the fees for up to 15 PACs so please reach out if your PAC has a tight budget would still like to support our efforts at the provincial level. Deadline to submit registration and membership dues is December 31. Any PACs wishing for COPAC to cover fees, please reach out by December 1.
- We continue to work with our DPAC colleagues across the province to bring issues facing students and families in BC Public Education to light. For the last several years, this has been taking place informally via a group we have been referring to as the DPAC Coalition. This group is considering becoming more formal and we will share those details with PACs in the coming weeks.
